Sub:- Registration of PIAs on caaa.gov.in-website.

Madam/Sir,

In our constant endeavors towards ease of doing business; This division has created a website caaa.gov.in for accessing the information, e-submission of claims by Project Implementing Agencies, to monitor the status of claims, e-submission of annual receipt budget information etc.

Authorized Signatories of Project Implementing Agencies (PIAs) are required to register through this website. This is necessary in view of the cyber security and to limit the access of authorized officers only.

The process of registration is as follows :-

1. Provide the following details/information to this office at the email id: controllercaaa-dea@nic.in :
  - i) Name of Project Authority
  - ii) Loan Number, Funding Agency Name
  - iii) Email Id, Mobile Number
  - iv) Address, Town/City/District, State, PIN Code, Country

On receipt of the required information and after verification of this information; Project Implementing Agencies will be provided with a **login ID** and **password**. PIAs will be able to change the password to ensure that there is no security breach.

This Division organized a series of Webinar to familiarize Project Implementing Agencies with e-submission of claims and e-submission of budget information. Huge participation of PIAs deserves appreciation. Now this familiarization needs to be translated into online registration of PIAs.

All the PIAs are requested to register by 28.09.2022.

In the next logical step PIAs are requested to start :

- (i) e-submission of claims starting from October, 2022 onwards; and
  - (ii) e-submission of Receipt Budget information between 1<sup>st</sup> October to 10<sup>th</sup> October each year, starting from this year i.e. 2022

There are about 395 loans and grants in disbursement phase as on date. This division launched a website [caaa.gov.in](http://caaa.gov.in) for digital flow of information related with claims, loan ledger Budget etc. This reduces the various communication gaps caused by slow movement of information in physical mode.

Project Implementing Agencies dealing with 155 loans/grants including you have already registered and providing various information including RE & BE figures online. Your authorized signatories have registered through website but have not utilized the Budget Utility till date.

Since annual Budget exercise is in full swing and various stakeholders including Budget Division, Economic Division and Public Finance State Division are pressing hard for aggregate figures of RE 2022-23 and BE 2023-24 related with Externally Aided Projects,

You are again requested to provide the RE 2022-23 and BE 2023-24 data related with External loans/grants by 14.10.2022. Lack of this information is likely to create problems in smooth fund flow and PIA shall be solely responsible for such an eventuality

Please refer to this Office Letter dated 21<sup>st</sup> September, 2022, wherein this Division had requested all PIAs to provide details for registration on our newly launched web site. Login id and password of all PIAs who have provided the details have already been sent on their respective e-mail id.

This division is responsible for preparation of estimated receipts from External Funding Agencies in case of Externally Aided Projects. These estimates are in turn utilized by Budget Division and Department of Expenditure. Further, these estimates are an important indicator in monitoring the progress of Externally Aided Projects.

Since the website of CAAA (caaa.gov.in) is functional, it was requested to provide the budget related information for Revised Estimates 2022-23 and Budget Estimates 2023-24 directly on website.

Most of PIAs have already registered through the website. There is no response your PIA is left behind and may face problems in smooth fund flow in future.

Therefore you are requested to

- (1) Immediately register on caaa.gov.in; and
- (2) Then provide the RE 2022-23 and BE 2023-24 in respect of External Loans/grants being utilized by your P.I.A. through budget utility available on caaa.gov.in.

Please complete both these actions by 14<sup>th</sup> October, 2022.
